Consultative Services Update – Bruce Pearson

- CSB has incorporated the SEP into their surveys. They have done 11 applicable surveys so far, but they have experienced some coding issues, which are causing rejects. The issue is being worked on.

PSIM Update – Anne Weaver

- The mailing list was provided to ETTA for the letters.

ETTA Update – Hollis Yelverton

- They have incorporated an Amputation SEP update into some of their webinars and in one of the alliances/partnerships.
- The mailings have gone out and they have not seen a lot of returned mail, which is a good sign. There were 2 addresses for most of the employers on the list.
- Fed OSHA put their National Emphasis Program in the Amputation Directive; we have not decided on utilizing the coding.

Compliance Update – Jennie Cagle

- On November 15, 2020, there were 1,700 letters mailed to employers that fell within the guidelines in the OPN. The goal of the letter was to inform the employer of the SEP.
- Prior to the letter being sent out, a copy was sent to all OSH staff in the event they are asked questions about the letter when in the field.

The employers that were selected are based off the OPN E.2.a.v. "NAICS codes with three or more "Amputation-Digit," "AmputationLimb," or "Pulled into Machinery" events ($n \geq 3$) and an event rate greater than or equal to 1.5 per 1000 NC employees over the four-year data period (calendar years 2015-2018) will be included in the initial targeting schedule." They encompass the italicized NAICS codes in Appendix A of the OPN.

A copy of the letter will be emailed as soon as Hollis is back in the office tomorrow since Kevin made his revisions to the most recent draft of the letter.
