UPDATES

Consultative Services – Bruce Pearson

- Robbie is moving and Marcus Bandy has agreed to take his place and will be reporting for Consultative Services in the future.
- To date 34 surveys have been conducted and coded as Amputation SEP. The group continues to focus surveys on LOTO and guarding issues known to cause amputation injuries.

ETTA – Joseph Davis

- ETTA added 10 OSHA 10 & 30 courses to the schedule this year and these extra classes should be completed in the Spring. A new guarding/LOTO class for new compliance officers is being developed to help focus on machine guarding and LOTO issues.

PSIM – Karen Padgett

- No updates.

West Compliance – Paul Sullivan

- Continues to review inspection data; Provided some Amputating inspection data that indicates that the Amputation SEP inspections are the most effective Programmed Planned inspection.
- Paul indicated that approximately 3 out of 5 programmed planned inspections result in Serious, Willful, or Repeat Serious citations. These inspections have only resulted in 2 or 3 contested cases.
- Reviewed the difference between LOTO and Guarding citations. If an accident happened while conducting service and maintenance activities, it should generally be cited under LOTO. If the employee was not conducting service and maintenance, it should generally be cited under machine guarding.

East Compliance – Nicole Brown

- Outlined the current number of released CSHO's, CSHO's in training, and vacant positions in the East Bureau.

Case File Study – Ted Hendrix

- Ted presented a case file study of a multi-digit amputation involving a full rotation mechanical power press.
- The injury resulted from a failure to utilize a two-handed control to activate the press.
- Several meeting members had questions that resulted in good communication among the group.

- George Calvery asked for a volunteer to present a case file study at the next meeting. Paul said he would step-in with a presentation if there are no volunteers.
