	<p>Notes</p> <ul style="list-style-type: none"> • Our compliance activity at the moment is remarkable. We have until September 30 2018 to conduct 25 more LTC inspections. Consultative seems to be right on schedule as well. • As you can see the national average and state DART and Total Recordable Case rates continue to decrease. This is a testament to all of the services that we provide throughout the year. The state rates are currently below the national average. • In the future, we will be reviewing reports again to ensure that we are addressing the elements of a long term care compliance inspection and following OPN 132H. At the conclusion of the review, we will be providing feedback for the East and West. We will also be evaluating reports to ensure that partial inspections have documentation to show whether an expansion of the LTC elements were considered. • In mid April all of the SEP committees will be meeting to discuss goals for the upcoming FFY 19, which will be the start of a new 5 year strategic management plan. If you have any suggestions for our committee in FFY 19 please give me a response by April 1, 2018. <p>Thanks for everything that you do!!!!!!!!!</p>
