### **Open Discussion:**

RE: VA arborist standard

- What is the difference between a “Rule” and a “Guide”?

Hollis explained the comparison and notes that a guide supports existing regulations. A rule formalizes guidance. This six(plus) month process requires initial management support, requires the Standards office to contact the Department’s “rule-making coordinator” (Jill Cramer, Legal Affairs) and initialization of a number of committees and subcommittees which will be tasked to address specific portions of the proposed rule. We/OSH would have to show/justify a “need” for a rule in NC, create a fiscal document/note to show the financial impact (primarily to the employer) as well as the State. The offer the document for a public hearing and allow for public comment. Standards would address the specific wording as influenced by any public comments and internal discussions.

Hollis envisions something like a Standards Notice for our product.
