- Putting it all together in an OSHA 1b



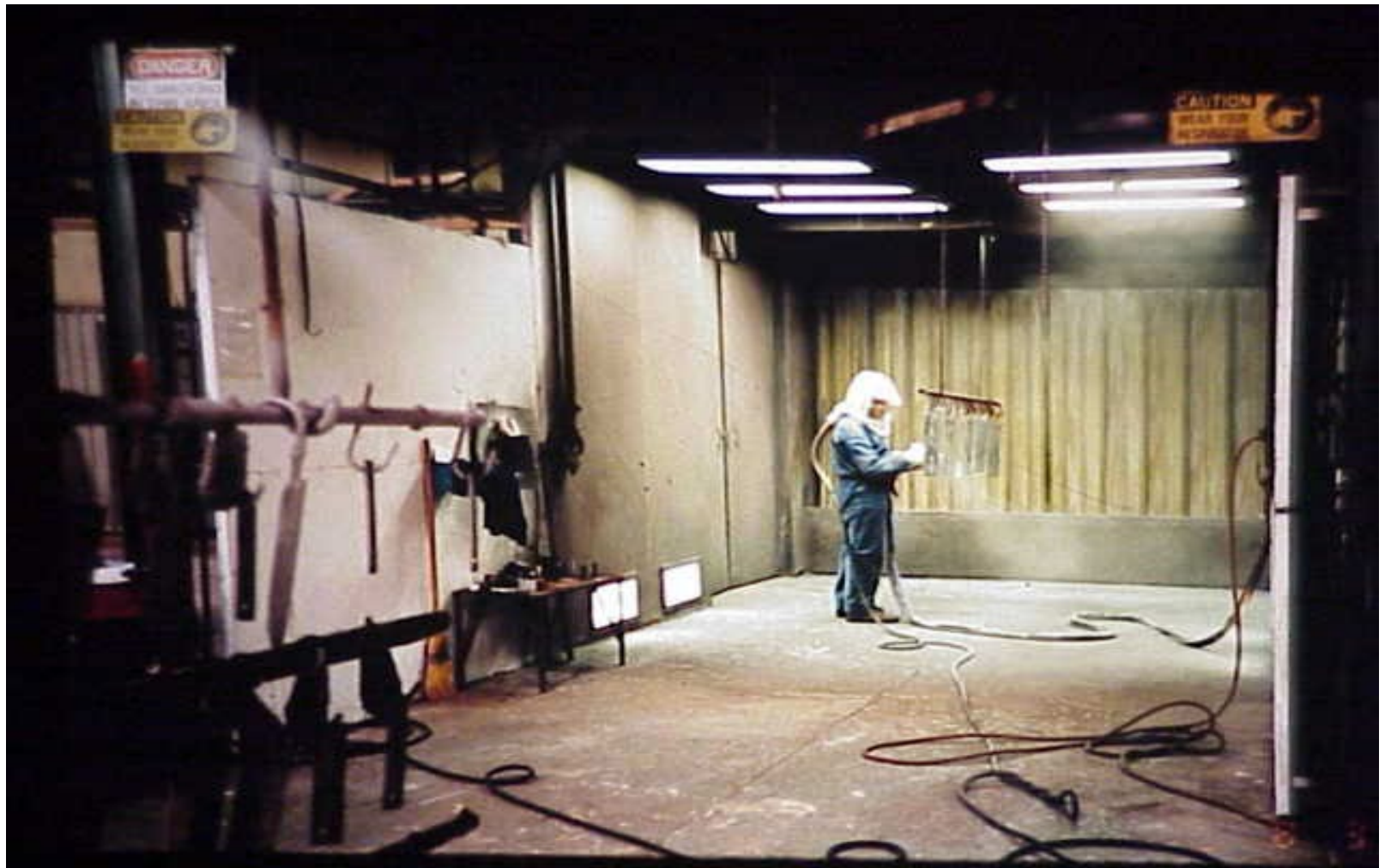

Air Sampling

- When is air sampling necessary?
 - Complaints?
 - General Schedule?
 - SST Inspections?
 - Special Emphasis Programs (e.g. Lead, Silica)?
- Can you do screen sampling?
 - What equipment is available for screening?



Air Sampling

- Which contaminants do you sample for?
 - MSDS's
 - Use of “profile” sampling
 - What type of media?
 - Sampling flow rates
 - Total sampling volume



Air Sampling

- **Sampling procedures**

- Which employees will you sample?
- Pump placement/securing
 - » Tubing
 - » Welding helmets
 - » Supplied air respirators
- How do you handle lunches/breaks?
- How do you handle pump faults?

Expanded Health Standards

- Standards promulgated by 6(b) rulemaking, including:
 - Asbestos
 - Lead
 - Formaldehyde
 - Methylene Chloride
 - Cotton dust
 - A number of carcinogens



Case Studies



Expanded Health Standards

- The OSH Act under paragraph 6(b)(7) specifies what must be included in these standards:
 - Exposure monitoring or measurements
 - Appropriate PPE
 - Labeling and employee training
 - Medical surveillance



Expanded Health Standards

- What procedures will you follow when a regulated contaminant is identified?
 - Monitoring results
 - Written compliance program
 - Medical records
 - Training records
- Will you need to sample?
- How will this info be confirmed?



Bloodborne Pathogens

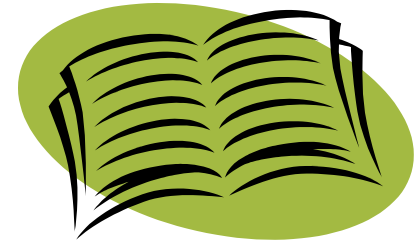
29 CFR 1910.1030

- Who is covered by this standard?
- How about First Aid providers?
 - Collateral duty
 - Post exposure HBV Vaccinations
- How can training and HBV Vaccinations be confirmed?

 - 1910.38 – Emergency action
 - 1910.95 – Noise
 - 1910.146 – Permit-Required Confined Spaces
 - 1910.147 – LO/TO
 - 1910.1000 – PELs
 - 1910.1030 – BBP
 - 1910.1xxx – Expanded Health Standards
