- Personnel update
  - Current Status out of **55 CSHO positions** (26 Health and 29 Safety).
    - **37 released CSHOs (67%)** – 20 Health (77%) and 17 Safety (60%)
      - There are also two HCOs that were previously released SCOs. They are technically in training, but still available to do inspections, so the HCO release rate is actually 84.6% when including them.
    - **7 CSHO Trainees (13%)**
      - SCO Jennifer Hartle started 6/27/2022 in CLT District 2.
      - As noted above, two HCOs in training have previously been released SCOs.
    - **11 vacancies (20%)**
      - SCO Glenn Adam Key (D5, WS) starts 8/15/2022
  - Where is the West BC?
