Document Title: **Inspection and Testing/Inspection and Test Status**

Effective Date: **October 1, 2011**

Approval Authority: **Bureau Chief**

A. PURPOSE

This establishes a procedure for inspection and testing of Planning, Statistics and Information Management Bureau (PSIM) services before completion.

B. SCOPE

This procedure applies to PSIM Bureau personnel using inspection and testing steps as required to produce PSIM services. Services include: OSH Targeting System, Disclosures, Case File Management, Construction Targeting, Public Sector Survey and Targeting, OSH Database Management, Occupational Fatality Inspection Review (OFIR), Performance Indicator Report (PIR) and OSH Strategic Management Plan (SMP).

C. DEFINITIONS

- A. PSIM Inspection and Testing** - PSIM employees may use inspection and testing techniques as a way to review, analyze, and check their work before a particular service may be released to a customer.
- B. Inspection and Test Status Definition** - PSIM definitions for this procedure are contained in the individual operating procedures in BOP 4.09 Process Control.
- C. Signed Packing List/Receipt** - Evidence that an incoming product or material was inspected by PSIM Bureau staff.

D. RESPONSIBILITIES AND AUTHORITIES

PSIM Bureau Personnel - PSIM bureau personnel use inspection and test methods for final production of bureau services as required by each individual employee. Inspection and testing is completed based on the experience and job knowledge of each employee. Action steps for inspection and testing are included in **BOP 4.09 Process Control**.

E. REQUIREMENTS

F. ACTION STEPS

1. Processes for each PSIM service for inspection and testing are contained in **BOP 4.09 Process Control**.
