Virginia OSHSPA Meeting

NCDOL had a large presence at the latest OSHSPA meeting held in Roanoke, Virginia at the end of August. Nine staff attended the meeting. This was Kevin Beauregard's last meeting and Jennifer Haigwood's first, representing NCDOL as the Deputy Commissioner. OSHSPA is the Occupational Safety and Health State Plan Association, an organization of 29 states and territories that have OSHA-approved state plans. OSHSPA is the link between state plans, federal OSHA, and Congress. OSHSPA representatives meet three times a year to exchange information and address shared concerns. OSHSPA representatives also appear before congressional committees and other hearings to report on workplace safety and health matters.

During these meetings, OSHSPA members meet as a group first before meeting later with and presenting information to the federal OSHA representatives. Staff meet to discuss and try and improve on or resolve ongoing issues.

Newest State Plan

The Massachusetts Department of Labor Standards (the DLS) has submitted a developmental State Plan for occupational safety and health, applicable only to state and local government employment (workers of the state and its political subdivisions) (Massachusetts State Plan), for determination of initial approval under Section 18 of the Occupational Safety and Health Act of 1970 (the OSH Act). OSHA proposes to grant the Massachusetts State Plan initial approval based on its preliminary assessment that the Massachusetts State Plan meets, or will meet within three years, OSHA's State Plan approval criteria, and that Massachusetts has provided adequate assurances that it will be at least as effective as Federal OSHA in protecting the safety and health of Massachusetts state and local government workers. OSHA proposes to fund initial approval of the Massachusetts State Plan from the State Plan funding available in the Department of Labor's Fiscal Year 2022 budget. Massachusetts was inducted into the Occupational Safety and Health State Plan Association at its August meeting

Coming Soon: Upgraded One Stop Shop

In January 2022, NCDOL and ET&A entered into a contract with Atlantic BT, a Raleigh-based web design and software company, to upgrade and improve the current One Stop Shop. It will have all the information of the old One Stop, but with new layout and design. It will be much more navigable AND feature a working search function. Each user will be able to save their own "favorites" for easy accessibility and "unsave" them when they are no longer needed. It will also show all recently uploaded documents on the user's "home" page. The new One Stop Shop will be available this fall. Thank you to all the staff that are making this happen.

Labor Rights Week

Through our alliance with the Mexican Consulate, Alta Guzman and Jay Cronley participated in the Labor Rights Week event (August 29-September 2) at the Mexican Consulate in Raleigh. Alta and Jay hosted an OSH booth and presented information to small groups of consulate clients in Spanish. Alta also participated in their celebratory ribbon cutting to kick off the week. Labor Rights Week (LRW) is an initiative that seeks to raise awareness and inform the Mexican and Latino communities about their fundamental labor rights. During this event, DOL staff had an opportunity to meet people from many walks of life including diplomatic representatives from México and other Latin American countries, the liaison of Latino affairs from the NC Governor's office, representatives from other federal/state agencies, higher education institutions, trade associations, non-profit organizations and the general public.
