- Health Hazard Assignment

- Grant will continue to receive the DHHS lead and Asbestos referrals.
 - Karen will update list through PSIM. Can always pull more NASICS codes for additional inspections.
 - Referrals are sent to supervisors.

- Dry Cal Calibration

- CSHO concerned that their primary calibration standard was past due and would need to void samples.
 - A review of the status of orders with manufacturer, revealed a back log and provided an estimate for return to OSH district offices.
 - In the interim, CSHOs can continue to use calibrators until the receive the one that are being serviced.
 - Samples do not need to void. A review with the manufacturer and internal discussions showed that the way NC DOL uses, stores, and maintains the calibrators, they are expected to be within tolerances and can continue to be used until newly serviced units are received.
