Shipyard Employment and Marine Terminals Maritime Standards

DISCUSSION:

There has been a portion of public sector employees involved in maritime operations who fall outside the realm of protection of federal OSHA maritime standards. Therefore, the Division of occupational Safety and Health has promulgated applicable portions of the maritime standards into the North Carolina Administrative Code. These newly incorporated standards, 29 CFR 1915 - Occupational Safety & Health Standards for Shipyard Employment and 29 CFR 1917 - Occupational Safety and Health Standards for Marine Terminals, will become effective December 1, 1993. Hazards not covered by these newly promulgated standards may be cited under the General Industry Standards.

ACTION:

The final rules at 29 CFR 1915 - Occupational Safety & Health Standards for Shipyard Employment and 29 CFR 1917 - Occupational Safety and Health Standards for Marine Terminals are incorporated by reference into the North Carolina Administrative Code by the Commissioner of Labor with an effective date of December 1, 1993. These standards shall apply only to public sector employees of local governments or of the State of North Carolina. Copies of the regulatory text as of July 1, 1990, and the incorporating text from the **North Carolina Administrative Code** at 13 NCAC 7F.0500 are attached.

SECTION .0500 - MARITIME STANDARDS

.0501 SHIPYARD EMPLOYMENT

.0502 MARINE TERMINALS
