- Worker Memorial Day – Friday, April 28
  - Commissioner Dobson is joining representatives from the state AFL-CIO for this annual press conference and memorial service.
  - Event is taking place on the south side of the Capitol building (Morgan St. side)
  - Open to the public and anyone can attend
- Agency Bill
  - Senate Bill 542 (DOL / Omnibus Law Changes) was heard in the Senate Commerce Committee today at 1 pm. No questions or comments, and the bill passed the committee unanimously on a voice vote.
  - The bill is scheduled to be heard tomorrow (Apr. 26) in the Senate Judiciary Committee. After Judiciary, the bill will go through the Rules Committee and finally to the full Senate for a floor vote.
  - As a reminder - specific to the OSH Division, Section 6 amends the OSH Act by allowing for electronic issuance of citations, and Section 8 repeals Article 22 (Safety and Health Programs and Committees).

**Paul Sullivan – Assistant Director's Report**

- OPN 149A (Amputations SEP revisions) has been completed and signed. Thanks to ETTA for their help on review and formatting. I will be sending out an email today to all the district supervisors and BCs with a summary of the changes, which primarily involve the targeting system and the coding.
- The hiring of CSHO trainees seems to be going well, HCO probably better than SCO to this point. We currently have four true HCO trainees in the East and one in the West – with one scheduled to start in late May. We also have two at the hiring package/conditional offer stage in the West.

- All trainees will serve a two-year training program before being considered “fully qualified.” The only exception will be SCO trainees that come in with some experience. Once they reach that two-year mark, they will be bumped to the starting salary for the fully qualified HCO or SCO. They may receive a bump at the one-year mark, but that will depend on any legislative increases received.
- The OSHA 125 course is planned for June 5-15 in Charlotte. The class will be limited to the new HCOs. The agenda has been set, but the instructors may change a bit as I’m looking to add a couple more of our CIH’s to the class – namely Ushang Desai and Matt Gruber.
- The Vent Conference is May 8-11 in North Raleigh. I will be in and out that week as I juggle work and teaching. We will have four of our new CSHOs there.
