- Agency Bills are passing through in the Senate: one allows us to serve citations electronically; another is on repealing Article 22, and the last is one that affects the OSH Division’s ability to adopt federal changes verbatim.

Library, Nick Vincelli

- Renewed subscriptions to Streamery (streaming safety/health video service) and Reference USA subscriptions last month (both were wish list items and were submitted in NC E-procurement after review by Legal Affairs Division, etc.). Both subscriptions will expire Aug. 2024.
- Loose ceiling tile in the stacks area was promptly repaired by Facilities Mgmt (per Charity’s work order)—Carlene noticed this during a safety inspection walk-through.
- Attended RALLA meeting and SHSC meeting since last meeting.

Recognition Program, LaMont Smith

- Kiley and Melodie are doing a great job organizing and working with co-sponsors, preparing banquets and certificates, and processing paperwork. At this time, nine banquets have been completed.
- Special Star Team Member (SSTM) Training was conducted on March 7 – 9, 2023 in Raleigh and March 15 – 16, 2023 in Winston Salem. A total of 20 SSTMs and one OSTM participated in initial training and four SSTMs were recertified. Since the inception of the SSTM Training Program, the Star Program has trained more than 350 OSTM/SSTMs.
- Michelle and Melodie did a great job at sending out and receiving Star Annual Reports (SARs). All SARs have been submitted by the Star companies except for two.

Standards

Cory:

- I participated in the NUCA podcast in March. The topic was NUCA's "Think Inside the Box" initiative, and we talked about it. The initiative started Colorado, and NUCA of the Carolinas has forwarded the podcast to their group in Colorado, as well as National NUCA so we now have a podcast that has gone nation-wide.
 - Every S&RM meeting this year will be focused on trench safety, and Lee Peacock will be attending the next meeting in May since it will be near Charlotte and I will be out of town.
- The Health Hazard SEP committee met last week, and they are looking to meet their numbers for the year.
 - They are reviewing the numbers for the next year's goals, and they look to be returning them to the pre-COVID numbers
 - During the current Strategic Management Plan review, they are looking at removing asbestos from the SEP and replacing it with another contaminant. They are still looking into possible replacements.
- I will be attending the upcoming Federal Field Safety and Health Committee meeting, that is being hosted by Federal OSHA.
- from the NC Emergency Management, Hurricane season in NC starts June 1st. This year the prediction from the folks at NC State is 6-8 storms to affect NC, with 2-3 having major impacts to NC.
 - The statewide hurricane exercise will take place May 10-11 and Hollis will be covering for NC DOL.
 - We will be in conversation with the folks at NCEM about our roles and responsibilities within the state's emergency response. We have a meeting with them on May 3rd to restart the discussion. Hollis and Wanda originally met with them in January, but their Human Services Group leadership has changed so we are starting the process over.
 - In conjunction with this conversation, we will be reviewing our State Emergency Response Plan (SEMP) for potential revisions. This will include a revision of the Homeland Security/Emergency Response Team (HLS/ERT) roles and responsibilities. We hopefully will be revitalizing the team by the end of the summer/early fall.
- I will be teaching at the upcoming OSH 125 course in June (4 topics). Thank you to the training group for allowing me to continue to participate in training.
- I will be attending the ASSP Safety 2023 conference in San Antonio June 5-8.
