Jacobs Engineering- Mark Rasdall is the Team Leader. Team members include Kaye Thibodeaux, Todd Waller, Gregory Greene and James Washington. The project is the \$1.8 million mammalian cell culture plant for Fujifilm Disynth. The construction site is approximately 150 acres in Holly Springs (Wake County); the facility will be approximately one million square feet and once complete, will be the largest drug-manufacturing plant in North America. Did a walkthrough on August 10th. Trainees were involved and no serious hazards were observed. November 30th is the next walkthrough.

Holder- CLT- Buddy Amerson is the Team Leader. Team members include Nelson Edwards, Carl Burgette, Starsky Martin, and Tim Hogan. The overall project is a \$600 million terminal expansion at the Charlotte-Douglas International Airport. The project is being completed in phases with initial work beginning in 2019 and expected completion in 2025. The expansion will include doubling the interior lobby space, along with additional space for security lanes, ticketing and baggage claim. Additionally, a canopy will be added over a new eight-lane elevated roadway in front of the terminal lobby. An application to extend the partnership was signed on September 27th. We will have this partnership through phase 5. January 17th will be the first walkthrough of the site.

Witney Turner – Morgan Brown is the Team Leader. The overall project is a Warp Speed Silicon Carbide Plant. The signing process will be on November 6th. The first walkthrough is scheduled for some time in January.
